AN ORDER CREATING THE INTERIM CITY OF IMUS CULTURE AND THE ARTS COUNCIL

WHEREAS, Section 16 of the Local Government Code of 1991 provides that local government units shall, within their respective territorial jurisdictions, ensure and support, among other things, the preservation and enrichment of culture;

WHEREAS, Section 458 (5) (xvi) of the Local Government Code of 1991 provides that part of the powers of the Sangguniang Panlungsod is the establishment of a local council whose purpose is the promotion of culture and the arts, coordinate with government agencies and non-government organizations and appropriate funds for the development and support of the said council, subject to the availability of funds thereof;

WHEREAS, City Ordinance No. 04-132, s. 2019 created the City of Imus Culture and the Arts Council, defining its functions and appropriating funds thereof;

WHEREAS, Section 2 of Executive Order No. 86-A, s. 2021 titled "An Order Reorganizing the City of Imus Culture and the Arts Council", states that at the end of the term of office of the members of the Council, an interim council, headed by the Head of the City Imus Tourism, will be recognized until the new council membership is convened.

WHEREAS, the City Tourism and Development Office proposed for the amendment of City Ordinance No. 04-132, repealing or modifying some provisions to clarify the overall function of the Council, the tourism office, and the technical working group, and to streamline the composition, and powers and functions of the Council to be consistent with the DILG Memorandum Circular No. 2002-81, titled "Creation of Local Culture and Arts Council."

NOW, THEREFORE, I, ALEX L. ADVINCULA, Mayor of the City of Imus, by virtue of the powers vested in me by law, do hereby order:

Section 1. Composition - There is hereby created the Interim City of Imus Culture and the Arts Council.
