AN ORDER RE-DESIGNATING THE MEDICAL CONTROLLERS FOR THE CITY EMERGENCY MEDICAL SERVICES IN RESPONSE OPERATIONS

WHEREAS, during emergency response operations, particularly in vehicular accidents and other emergency situations, a medical controller is needed to supervise and coordinate emergency medical services.

WHEREAS, the City Disaster Risk Reduction and Management Office has no station-based physician to act as a medical controller during emergency response operations.

NOW, therefore, I, ALEX L. ADVINCULA, Chairperson CDRRMC, Mayor of the City of Imus, by virtue of the powers vested in me by law, do hereby order the designation of medical controllers for the City Emergency Medical Services in Response Operations:

Section 1. Designation- The physicians from the City Health Office and Ospital ng Imus shall be designated as Medical Controllers for CDRRMO EMS in Response Operations. For this purpose, **Dr. FERDINAND P. MINA**, as the City Health Officer is responsible in designating the available physician to ensure timely and immediate during emergency operations.

Section 2. Repealing Clause- Previous issuances or any portion thereof which are inconsistent with the provisions of this Executive Order are hereby amended, modified, superseded or repealed accordingly.

Section 3. Effective Clause- This Executive Order shall take effect immediately upon the approval hereof and shall remain in full force and effect unless sooner revoked or amended.
