**AN ORDER RECONSTITUTING TRICYCLE FRANCHISING REGULATORY
COMMITTEE (TFRC)**

WHEREAS, Ordinance No. 2004-46 as amended by Ordinance No. 03-102 Series of 2018 known as "*Comprehensive Code on Tricycle Franchise of 2018*" provides for the establishment of Tricycle Franchising and Regulatory Committee;

NOW, THEREFORE, I, HON. ALEX L. ADVINCULA, City Mayor of the City of Imus, by virtue of the powers vested in me by law, do hereby order the following:

Section 2. Powers of Tricycle Franchising Regulatory Committee –


- 2.1 To recommend to the City Council, in order to meet the needs of commuting public, the increase the number of franchises;
- 2.2 To grant, deny or withdraw the accreditation of tricycle operators and driver's associations;
- 2.3 To recommend to the City Council changes that may be made for the more effective implementation the Comprehensive Code on Tricycle Franchise;
- 2.4 Other powers necessary, appropriate or incidental in pursuance of the Code proper regulation of the tricycle sector;

Section 6. Repealing Clause- All issuances inconsistent with the provisions of this Order is declared are hereby repealed or modified accordingly.

Section 7. Separability Clause- If, for any reason, any part or provision of this Order is declared invalid or unconstitutional, any part or provision not affected thereby shall remain in full force and effect.

Section 8. Effectivity- This Executive Order shall take effect immediately.
