**AN ORDER REORGANIZING THE CITY OF IMUS DEVELOPMENT COUNCIL
(CIDC)**

WHEREAS, pursuant to section 106 of Republic Act No. 7160, each local government unit shall have a Local Development Council (LDC) that shall assist the Sanggunian in setting the direction of economic and social development and in coordinating development effort within its territorial jurisdiction;

WHEREAS, the Local Development Council is the body mandated to prepare the comprehensive multi-sectoral development plan and public investment program of the Local Government Unit;

NOW, THEREFORE, I, ALEX L. ADVINCULA, Mayor, City of Imus, Cavite, by virtue of the powers vested in me by law, do hereby order:

Section 1. TITLE- This Order shall be known as "**An Order Reorganizing the City of Imus Development Council (CIDC)**".

Section 2. COMPOSITION- The City of Imus Development Council is hereby reorganized with the following composition:

Section 3. FUNCTIONS- The City of Imus Development Council shall exercise the following functions:

1. Formulate long-term, medium term and annual socioeconomic development plans and policies;
2. Formulate the medium-term and annual public investment programs;
3. Appraise and prioritize socioeconomic development programs and projects;
4. Formulate local investment incentives to promote the inflow and direction of private investment capital.
5. Coordinate, monitor and evaluate the implementation of development programs and projects; and

6. Perform such other functions as may be provided by law or competent authority.

Section 4. EXECUTIVE COMMITTEE- An Executive Committee is hereby created to represent and act on behalf of the City of Imus Development Council when it is not in session. The composition of the Executive Committee is as follows:

Section 5. POWERS AND FUNCTIONS OF THE EXECUTIVE COMMITTEE-

The Executive Committee shall exercise the following duties and functions:

1. Ensure that the decisions of the council are faithfully carried out and implemented;
2. Act on matters requiring immediate attention or action by the council;
3. Formulate policies, plans and programs based on the general principles laid down by the council; and
4. Act on other matters that may be authorized by the council.

Section 6. SECTORAL AND FUNCTIONAL COMMITTEES- The Sectoral or Functional committees shall directly establish linkages with NGAS and other such sectoral or functional committees organized by the government for development, investment, and consultative purposes to ensure policy coordination and uniformity in operational directions.

Each member of the CIDC shall, as far as practicable, participate in at least one (1) sectoral or functional committee.

The City Local Government Operations Officer shall (1) ensure that the sectoral committees and other bodies created by virtue of existing national laws and administrative issuances shall be made standing committees of the CIDC; (ii) make certain that functional committees and other ad hoc bodies which may be formed from time to time shall, to the extent possible, be drawn from the membership of the sectoral committees, and (iii) emphasize the important role of the executive departments in planning by requiring each department head or any key officer thereof to join at least one sectoral or functional committee.

Section 7. SECRETARIAT- The secretariat of the City of Imus Development Council (CIDC) shall be headed by City Planning and Development Coordinator which shall be responsible for providing technical support, documentation of proceedings, preparation of reports and such other assistance as may be required in the discharge of its functions. The CIDC is highly encouraged to avail of the services of any CSO or educational or research institution for this purpose.

In addition, the staff of the City Planning and Development Office shall be involved with the CIDC in providing technical support, documentation of proceedings, preparation of reports and such other assistance as may be required.

Section 8. MEETINGS AND QUORUM- The City of Imus Development Council shall meet once every six (6) months or as often as may be necessary.

Section 9. RELATION OF CIDC TO THE SANGGUNIANG- The policies, programs, and projects proposed by the CIDC shall be submitted to *the sangguniang panlungsod* for appropriate action.

Section 10. FUNDING- The administrative and logistical support for its operations shall be charged to available local funds.

Section 11. REPEALING CLAUSE – Previous issuances or any portion thereof which are inconsistent with the provisions of this Executive Order are hereby amended, modified, superseded or repealed accordingly.

Section 12. SEPARABILITY CLAUSE - If any provision of this Executive Order is declared invalid or unconstitutional, other provisions not affected thereby shall remain valid and subsisting.

Section 13. EFFECTIVITY- This Executive Order shall take effect immediately.
