**AN ORDER CREATING THE LOCAL PUBLIC TRANSPORT PLAN (LPTRP)
TEAM OF THE CITY OF IMUS**

WHEREAS, under Department Order No. 2017-011 of the DOTR or the "Omnibus Guidelines on the Planning and Identification of Public Road Transportation Services and Franchise Issuance" or the Omnibus Franchising Guidelines (OFG), LGUs are given the task to propose Local Public Transport Route Plans (LPTRPs) for their respective areas. The specifications and requirements in constructing route plans are indicated in the Local Public Transport Route Plan Manual. One of the requirements in constructing LPTRPs is the selection of the appropriate public mode of transportation for the routes, depending on the passenger demand and the classification of roads.

WHEREAS, on June 19, 2017, the DOTr entered into a Joint Memorandum of Agreement with the DILG regarding the preparation of Local Public Transport Route Plans (LPTRPs) by the Local Government Units. This mandates the provinces, cities and municipalities outside of the Metro Urban and Capacity Enhancement Program (MUCEP) Study Area to prepare their respective plans in accordance with the DOTr Manual of Standards. The JMC-provides that the route plan shall detail the route network, mode and required number of units per mode in the delivery of public land transport services. Likewise, it stipulates that the plan is a minimum requirement for the Land Transportation Franchising Regulatory Board (LTFRB) issuance of franchises to public utility vehicles.

WHEREAS, in support thereof, DILG issued Memorandum Circular No. 2018-60 dated May 3, 2018, mandating LGUs on the preparation of the route plan, emphasizing the role of the DILG Regional Offices in the monitoring of LGUs compliance to the JMC.

WHEREAS, DILG issued a Memorandum dated June 24, 2021 advising the Local Chief Executives to intensify efforts in facilitating the preparation and submission of their LPTRP to the DOTr-LTFRB, and to ensure full support to the Public Utility Vehicle (PUV) Modernization Program

WHEREAS, the DILG issued Memorandum Circular No. 2021-139 dated 14 December 2021 reiterating DILG Memorandum Circular No. 2018-60 requiring all

provinces, cities and municipalities outside the MUCEP Study Area, to prepare their respective route plan for submission to the DOTr-LTFRB for approval.

NOW THEREFORE, I, ALEX L. ADVINCULA, City Mayor, City of Imus, Cavite, by virtue of the powers vested in me by law do hereby order the creation of the Local Public Transport Route Plan (LPTRP) Team of the City of Imus.

SECTION 1. COMPOSITION. The LPTRP Team shall be composed of:

SECTION 2. FUNCTIONS, POWERS AND DUTIES. The Council shall have the following functions, powers and duties:


1. Formulate the Local Public Transport Route Plan (LPTRP) based on and/or consistent with the LPTRP Manual prescribed in Joint Memorandum Circular No. 001, series of 2017, dated 19 June 2017 of the Department of Interior and Local Government (DILG) and the Department of Transportation (DOTr);
2. Shall be responsible in submitting the Local Public Transport Route Plan to the Land Transportation Franchising and Regulatory Board (LTFRB) for review, copy furnished the Department of Interior and Local Government (DILG), within six (6) months from the formal notice of the DOTr.
3. Facilitate the approval of the LPTRP Plan;
4. Perform additional tasks assigned as may be directed by the City Mayor in connection with the preparation and approval of the LPTRP.

SECTION 3. REPEALING CLAUSE. All other orders, issuances and memoranda issued inconsistent herewith are hereby repealed or modified accordingly.

SECTION 4. EFFECTIVITY. This Executive Order shall take effect immediately.
