**EXECUTIVE ORDER NO. 009**

**AN ORDER DESIGNATING HERTITO V. MONZON AS THE FOCAL PERSON OF THE CITY PEACE AND ORDER COUNCIL (CPOC), CITY OF IMUS ANTI-DRUG ABUSE COUNCIL (CIADAC), AND THE LOCAL TASK FORCE TO END LOCAL COMMUNIST ARMED CONFLICT (LTF-ELCAC) OF THE CITY OF IMUS**

**WHEREAS**, the undersigned issued Executive Order No. 07, Series of 2022 dated 19 August 2022 titled, "*An Order Reorganizing The City Peace and Order Council (CPOC)*".

**WHEREAS**, the undersigned issued Executive Order No. 67, Series of 2022 dated 28 November 2022 titled, "*An Order Reorganizing The City of Imus Anti-Drug Abuse Council (CIADAC)*".

**WHEREAS**, the Joint City Development Council (CDC) and the City Peace and Order Council (CPOC) issued *Resolution No. 2022-01* titled, "*Creation of the Imus City Task Force to End Local Communist Armed Conflict (LTF-ELCAC) Operation Center*".

**WHEREAS**, in the exigency of the service, there is a need to designate a single Focal Person in order to effectively discharge the duties and responsibilities of these critical Councils.

**NOW, THEREFORE, I, ALEX L. ADVINCULA**, Mayor, City of Imus, Province of Cavite, by virtue of the powers vested in me by law, do hereby designate MR. HERTITO V. MONZON, Officer-in-charge, City Administrator, as the Focal Person of the CPOC, CIADAC, and LTF-ELCAC.

**Section 1. DUTIES AND RESPONSIBILITIES.** Upon prior consultation with the City Mayor, MR. HERTITO V. MONZON, as the Focal Person of the CPOC, CIADAC, and LTF-ELCAC, is hereby authorized to perform any and all acts necessary to effectively discharge the duties and responsibilities of the CPOC, CIADAC, and LTF-ELCAC, within the limits provided by law.

**Section 2. REPEALING CLAUSE.** All Executive Orders, or a portion thereof, which are inconsistent herewith are hereby repealed or modified accordingly.

**Section 3. EFFECTIVITY.** This Executive Order shall take effect immediately.
