EXECUTIVE ORDER NO. 16

Series of 2022

AN ORDER IMPLEMENTING THE NO SEGREGATION, NO COLLECTION POLICY IN THE CITY OF IMUS

WHEREAS, the unsystematic waste disposal by households, institutions, industries, and commercial establishments causes unsightly surroundings, polluted environments and spread of various and dangerous and communicable diseases.

WHEREAS, Republic Act No. 9003, "The Ecological Waste and Management Act of 2000", provides for an ecologic solid waste management program, creates the necessary institutional mechanisms, declares certain acts prohibited and provides for penalties and appropriate funds thereof.

WHEREAS, Section 10 of the above cited Republic Act provides that "pursuant relevant provisions of Republic Act No. 7160 otherwise known as the "Local Government Code", the LGU shall be responsible for the implementation and enforcement of the provision of this act within their respective territorial jurisdiction.

WHEREAS, the City Government of Imus in compliance with Sec. 24 of Republic Act No. 9003 "The Ecological Waste and Management Act of 2000", the City of Imus is commits to adhere to and adopts the No Segregation, No Collection policy for the city.

NOW, THEREFORE, I, HON. ALEX L. ADVINCULA, City Mayor of Imus, by virtue of the powers vested in me by law, do hereby order all departments/offices of the city government of Imus, barangay councils, national agencies, private and public institutions, industrial and commercial establishments and all constituents of the city of Imus that effective October 1, 2022 "the no segregation, no collection policy" will be implemented. The proper segregation of waste shall be done in the following manners.

a. Biodegradable non-hazardous wastes shall be placed in plastic bags or sacks and the mouth tied tightly with any material colored green to prevent entry of insects and rodents, avoid spillage-at-source or upon collection by garbage vehicles and to facilitate identification and sorting by garbage collectors. Other receptacles may be used provided it is tightly covered or similarly tied. Improperly tied receptacles shall not be collected;

- b. The non-biodegradable, non-hazardous waste classified as disposable waste shall be placed in a black plastic bags or sacks and stored until the scheduled collection for such type of garbage. If <u>Recyclable Wastes</u> are found inside the plastic bag/sack, these will not be collected; and
- Special wastes from household, commercial, institutional establishments,
 - Hazardous household, commercial, industrial and institutional waste, such as batteries, fluorescent lamps, aerosol canisters and acids, shall be placed in a separate receptacle, properly covered or tightly tied with any material colored black and stored until its scheduled collection; and
 - Bulky waste, white goods, consumer electronics, large yard waste and agricultural waste shall be hygienically stored prior to schedule collection time.

NO WASTE FROM HOUSEHOLDS, ESTABLISHMENTS OR INSTITUTION in the City of Imus shall be collected unless it complies with this order.
