**EXECUTIVE ORDER NO. 29**  
*Series of 2022*

**AN ORDER ASSIGNING THE MANAGEMENT, OPERATION, AND DEVELOPMENT  
OF THE CITY SPORTS COMPLEX, CITY OF IMUS GRANDSTAND, AND TRACK  
OVAL TO THE CITY SPORTS DEVELOPMENT UNIT (CSDU)**

**WHEREAS**, Article XIV, Section 19 (1) of the 1987 Constitution provides that: "The State shall promote physical education and encourage sports program, league competitions, and amateur sports, including training for international competitions, to foster self-discipline, teamwork, and excellence for the development of a healthy and alert citizenry."

**WHEREAS**, Section 2 of the Local Government Code declares that the policy of the State that the territorial and political subdivisions of the State shall enjoy genuine and meaningful local autonomy to enable them to attain their fullest development as self-reliant communities and make them more effective partners in the attainment of national goals.

**WHEREAS**, the State shall provide for a more responsive and accountable local government structure instituted through a system of decentralization whereby local government units shall be given more powers, authority, responsibilities, and resources.

**WHEREAS**, in the exercise of such authority, the City Government of Imus intends to transfer the management, operation, and development of the City Sports Complex, Grandstand, and Track Oval to the City Sports Development Unit (CSDU) whose management was originally under the direct supervision of the Office of the City Mayor.

**NOW THEREFORE, I, HON. ALEX L. ADVINCULA**, City Mayor of the City of Imus, by the powers vested in me by law hereby orders the following:

**Section 1. Designation-** I hereby designate **Mr. PATRICK M. PAULME**, head of the City Sports Development Unit, to take charge of the management, operation, and development of the City Sports Complex, Grandstand, and Track Oval.

**Section 2. Authority-** As head of the CSDU, I hereby delegate to Mr. Patrick M. Paulme the authority to:

1. Transfer, reassign, designate, and deputize employees who are stationed or assigned or may hereinafter be stationed or assigned to the said facilities;
2. Recommend disciplinary action against the said employees for violation of Civil Service rules and regulations;

3. Recommend appropriate changes to develop, strengthen, and improve the said facilities in accordance with world standards;
4. Identify and recommend appropriate programs/projects plan and implementation;
5. Reform and reorganize personnel as he may deem fit, but ensuring in the process the protection of security of tenure of civil service employees.

**Section 3. Responsibilities-** In addition to his authority, Mr. Patrick M. Paulme shall have the following duties and responsibilities:

1. Maintenance of orderliness and cleanliness of the said facilities.
2. Scheduling of City Government Activities that will be conducted in the above-mentioned facilities.
3. Safeguarding the equipment, machineries, accessories, devices, and other vital facility items.
4. Public safety and security of all guests.
5. Preparation of all reportorial requirements relative to the management, operation, and development of the said facilities.

**Section 4. Repealing Clause-** Previous issuances or any portion thereof which are inconsistent with the provisions of this Executive Order are hereby amended, modified, superseded or repealed accordingly.

**Section 5. Separability Clause-** If any section or provision of this Executive Order is declared void, ineffective or invalid by a court of competent jurisdiction, the holding of such section or provision to be void or invalid for any cause whatsoever shall in no way affect the validity of the remaining sections and provisions, which shall remain in full force and effect.

**Section 6. Effectivity Clause** – This Executive Order shall take effect immediately upon the date hereof and shall remain in effect until rescinded, repealed or amended.
