#### **EXECUTIVE ORDER NO. 51**

Series of 2022

#### AN ORDER REESTABLISHING THE CITY OF IMUS DISASTER PREPAREDNESS AND RESPONSE MANAGEMENT CORE

**WHEREAS**, Republic Act No. 10121, otherwise known as the *Philippine Disaster Risk Reduction and Management System of 2010* mandates the LGU to institutionalize the implementation of the DRRM system in every locality in order to ensure the strengthening of its capacity towards establishing a resilient LGU.

WHEREAS, on March 20, 2012, the Sangguniang Bayan enacted Ordinance No. 130, organizing the Municipal, now City Disaster Risk Reduction and Management Council, by which the City had created the Municipal, now City DRRM Office to ensure that the mandates and the framework of the National DRRM Plans have been implemented and strengthened.

**WHEREAS,** to improve the DRRM and incident management set-up of the City, it constructed primary facilities in various strategic locations for Disaster Preparedness and Response.

NOW, therefore, I, ALEX L. ADVINCULA, Chairperson CDRRMC, Mayor of the City of Imus, by virtue of the powers vested in me by law, do hereby order:

- **Section 1. Reestablishment. -** The City Government of Imus hereby reestablishes the various DRRM facilities for Disaster Risk Reduction and Incident Management. These facilities shall primarily operate 24/7 as follows:
  - (a) **BUCANDALA OPCEN / ACTION AGAD CENTER** shall be re-assigned as the Main Office of CDRRMO, the City Operations Center as the central monitoring core which will place the City's CCTV Monitoring Unit, Weather Monitoring, Information and Alert Management, Emergency Coordination and Dispatching for Hotline and Radio Communication and Emergency Medical Response of the CDRRMO.

The BFP Responding Unit and Police Community Precinct No. 4 shall also be the Response Team relative to their mandates.

- (b) **ANABU ACTION AGAD CENTER** shall continue to establish the Preparedness and Response for Emergency Medical Response of the CDRRMO, the Public Safety core of the BFP, and the Police Community Precinct No. 2;
- (c) **MALAGASANG ACTION AGAD CENTER** shall continue to establish the Preparedness and Response for Emergency Medical Response of the CDRRMO, the Public Safety core of the BFP, and the Police Community Precinct No. 5;
- (d) **ESPELETA ACTION AGAD CENTER** shall continue to establish the Preparedness and Response for Emergency Medical Response and Training Facility of the CDRRMO, the Public Safety core of the BFP, and the Police Community Precinct No. 6;
- (e) **EVACUATION CENTER AND STOCKPILE FACILITY** shall be reassigned as the City's Evacuation Center and Stockpile Facility for preparedness and response:
  - e.1 Plaridel CDRRMO Logistics Hub Bayan Luma 7
  - e.2 Imus Sports Complex
  - e.3 All Public Schools
  - e.4 Multi-purpose and Covered Courts permitted by the Barangays and HOAs
- (f) **EMERGENCY MEDICAL FACILITIES** shall be re-assigned as the Trauma for Medical Facilities:

F.1 Ospital Ng Imus

- Trauma Response Facility And Field Hospital

F.2 Velarde RHU

Pre-Hospital Response

F.3 Bayan Luma RHU

- Pre-Hospital Response

F.4 Alapan RHU

- Pre- Hospital Response

F.5 Espeleta RHU

Pre-Hospital Response

#### (g) DATA AND COMMUNICATION ACCESS FACILITY:

- G.1 Imus City Hall Antenna Tower
- G.2 Robinsons Helipad Site Antenna Tower
- G.3 Anabu II Elementary Schools

**Section 2. Emergency Operational Protocols-** Any emergency caused by human or natural hazards which needs major mobilization of resources shall be centralized and shall be under the operational management of the Emergency Operations Center and response guide of the Incident Command System when activated by the undersigned as Chairperson of the CDRRMC.

**Section 3. Funding-** The source of funds to be utilized for its operations and improvement shall be charged against the DRRM FUNDS of the city and in the Local Development when necessary.

**Section 4. Effectivity-** This Executive Order shall take effect immediately upon approval hereof and shall remain in full force and effect unless sooner revoked or amended by the Local Chief Executive.
