EXECUTIVE ORDER NO. 56

AN ORDER REASSIGNING THE CITY DISASTER RISK REDUCTION AND MANAGEMENT OFFICE (CDRRMO), PRESENTLY LOCATED AT CITY OPERATIONS CENTER BUILDING BUCANDALA III, NIA ROAD AS THE CITY OPERATIONS CENTER FOR DISASTER RISK REDUCTION AND INCIDENT MANAGEMENT OPERATIONS

WHEREAS, it is the mandate of Republic Act No. 10121, otherwise known as "The Philippine Disaster Risk Reduction and Management Act of 2010", to institutionalize the Implementation of the DRRM system in every locality in order to ensure the strengthening of its capability towards establishing a resilient LGU.

WHEREAS, one of the basic components of the DRRM institutionalization is the establishment of the City's Operations Center which will house the Central Monitoring Systems, Communication Unit, the Hazard and Risk Profiles, and the DRRM Core.

WHEREAS, with the development of the Imus City Disaster Risk Reduction and Management Office, the enumerated set-up, CCTV Monitoring System, Weather Monitoring System, Automated River Watch, Communication Facilities, and the ability to establish the Hazard and Risk evaluation, have been established and the formal designation thereat, is duly recommended.

NOW, THEREFORE, I, ALEX L. ADVINCULA, CHAIRPERSON CDRRMC, CITY MAYOR OF THE CITY OF IMUS, PROVINCE OF CAVITE, BY VIRTUE OF THE AUTHORITY VESTED IN ME BY LAW, do hereby order:

Section 1. The Reassignment- The CDRRMO shall be reassigned as the City Operations Center for Disaster Risk Reduction and Incident Management Operations.

Section 2. Powers and Functions- The Operations Center shall have the following functions:

 The operations center shall be the central monitoring core for Incident Management Operations (Natural or Man-made) such as Emergency Medical Service, Fire Rescue, and Police Emergency Assistance.

- 2. It shall operate 24/7 Weather Monitoring and Information Messaging Operations.
- It shall serve as the Radio Communication Network Center for transmitting and receiving reports and coordination from the 97 Barangays;

Section 3. Funding - The development and improvement of the Operations Center shall be charged against the City Disaster Risk Reduction and Management Fund under the 70% Pre-Disaster Fund.

Section 4. Effectivity- This Executive Order shall take effect immediately. **DONE** and **SIGNED** this 9th day of September 2022, City of Imus.
