**AN EXECUTIVE ORDER OUTLINING, ADOPTING AND STREAMLINING THE FIVE (5)
POINT EXECUTIVE AGENDA FOR THE CITY OF IMUS**

WHEREAS, Section 455 Article I Chapter III of the Local Government Code provides that for efficient, effective and economical governance the purpose of which is the general welfare of the city and its inhabitants, the City Mayor shall exercise general supervision and control over all programs, projects, services, and activities of the city government and in this connection, shall direct the formulation of the city development plan and shall implement the same;

WHEREAS, in accordance with the foregoing mandate of the Local Government Code, an exhaustive study and assessment was made in order to determine the priority programs and agendas of the City Government of Imus;

WHEREAS, based on the study and assessment conducted, a Five Point Executive Agenda was formulated;

NOW, THEREFORE, I, ALEX L. ADVINCULA, City Mayor of the City of Imus, by virtue of the powers vested in me by law, do hereby order:

Section 1. In order to efficiently and effectively implement the City's Executive Agenda, the same shall be divided into five points, to wit:

- a) Health, Education and Social Services;
- b) Good Governance;
- c) Housing and Livelihood;
- d) Infrastructure; and
- e) Environment.

The foregoing shall be collectively known as the Five (5) Point Executive Agenda.

Section 2. Programs for Health, Education and Social Services shall focus on the improvements of the following:

- i) Creation and Expansion of Health Centers, Birthing Homes, Super Health Centers & Continuous Distribution of Free Maintenance Medicines;
- ii) Granting of Scholarships and Educational Assistance to Qualified Students;
- iii) Establishment of the City of Imus College (Enrollment to Employment Program);
- iv) Providing Medical and Financial Assistance (Unified Beneficiary Database Program);
- v) Online Transaction and Automation of Assurances;
- vi) Electronic Disbursement of Assurances;
- vii) Free Funeral Services; and

viii) Establishment of Alisto Imusenyo.

Section 3. Programs for Good Governance shall put emphasis on the following aspects:

- i) Elimination of Ghost Employees;
- ii) Transparency Through Internal Audit and Inventory;
- iii) Establishment of System for Accountable Governance;
- iv) Creation and Rollout of Business Tax Incentives to Promote Business Confidence to Investors; and
- v) Improvement of Queuing System in Government Offices.

Section 4. Programs for Housing and Livelihood shall cover:

- i. Relocation and Housing of Informal Settlers;
- ii. Opportunities for Senior High School to Secure Job Apprenticeship; and
- iii. Partnership with Private and Local Sectors for Livelihood Programs and Trainings.

Section 5. Programs for Infrastructure shall improve the following:

- i. Improvement of Cellular Network Signal (In Coordination with the Private Sectors);
- ii. Improvement of Water Supply (Proper Planning and Solution to Improve Different Services);
- iii. Creation of Additional Road Networks (For the Improvement of Mobility of Different Goods);
- iv. Installation of Additional Street Lights and Road Safety Devices and Signage;
- v. Improved Transport System for Commuters Through the Establishment of High Capacity Public Utility Vehicles);
- vi. Efficient Implementation of a New Traffic System; and
- vii. Implementation of Road Clearance.

Section 6. Programs for Environment shall constitute the following:

- i. Creation of Eco-Tourism in the City of Imus;
- ii. Proper Waste Segregation and;
- iii. Strategical Placement of Street Sweepers.

Section 7. It is mandated that all policies, agendas and programs of the City of Imus shall be in accordance and aligned with the Five (5) Point Executive Agenda.

Section 8. The foregoing Five (5) Point Executive Agenda is hereby adopted and all City Department Heads, Unit Heads and Officers-in-Charge are ordered to streamline a process for the proper implementation and execution of the Five (5) Point Executive Agenda.

Section 9. This Executive Order shall take effect immediately and shall be remain in full effect unless otherwise revoked.
