**AN EXECUTIVE ORDER DECLARING SUSPENSION OF CLASSES AT ALL LEVELS IN BOTH PUBLIC AND PRIVATE SCHOOLS AND SUSPENSION OF WORK IN ALL GOVERNMENT OFFICES AND AGENCIES IN THE CITY OF IMUS ON 23 JULY 2024 DUE TO INCLEMENT WEATHER**

**WHEREAS**, it is a declared policy of the State to uphold the people's constitutional rights to life, health, safety, and property and to promote the general welfare of its people at all times, especially during disasters and calamities;

**WHEREAS**, Section 3 of Presidential Executive Order No. 66, Series of 2012, provides that localized cancellation or suspension of all classes at all levels in both public and private schools may be implemented by Local Chief Executives, due to typhoons, flooding, and other weather disturbances and calamities;

**WHEREAS**, upon recommendation of the City Disaster Risk Reduction and Management Office (CDRRMO) of Imus City and in consideration of the inclement weather in the City of Imus, it is imperative to implement a localized cancellation or suspension of classes at all levels and to suspend the work on all government offices and agencies;

**WHEREAS**, Section 16 of Republic Act No. 7160, or the Local Government Code of 1991, provides that within their respective territorial jurisdictions, local government units shall, among others, ensure and promote health and safety and preserve the comfort and convenience of their inhabitants;

**WHEREAS**, Section 455 (b) (2) (iii) of the Code provides that the City Mayor shall issue such executive orders for the faithful and appropriate enforcement and execution of laws and ordinances;

**NOW, THEREFORE, I, HON. ALEX L. ADVINCULA**, City Mayor of the City of Imus, by virtue of the powers vested in me by law, do hereby order the **SUSPENSION OF CLASSES AT ALL LEVELS IN BOTH PUBLIC AND PRIVATE SCHOOLS AS WELL AS WORK IN ALL GOVERNMENT OFFICES AND AGENCIES** in the City of Imus on 23 July 2024.
