**AN ORDER ORGANIZING THE ASSESSMENT COMMITTEE FOR COMMUNITY MOBILIZATION PROJECT AS AMENDED**

**WHEREAS**, Section 16 of the Local Government Code, otherwise known as the General Welfare Clause, local government units are charged with the promotion of health and safety within their respective territorial jurisdictions;

**WHEREAS**, Community Empowerment and Mobilization through the Philippine National Police (PNP) can sustain active participation of the community by empowering them and by allowing citizens to share decision making and responsibilities with the police, as well as for the community to express their thoughts about which problems are important and need for solutions;

**WHEREAS**, community volunteers can be tapped to assist the law enforcement or community policing, support to internal security, disaster preparedness and response, environmental protection and preservation and conflict resolution;

**WHEREAS**, these volunteers may also be utilized in the conduct of crime prevention awareness and education, and other public information activities;

**NOW, therefore, I, ALEX L. ADVINCULA**, Mayor of the City of Imus, by virtue of the powers vested in me by law, do hereby amended the composition of the City Assessment Committee for Community Mobilization Project with the following provisions:

**Section 1. COMPOSITION** - The City Assessment Committee for Community Mobilization Project shall be composed of the following:

**Section 2. FUNCTIONS AND RESPONSIBILITIES** - The City Assessment Committee for Community Mobilization Project shall have the following functions and responsibilities:

- a. Assess and evaluate the implementation of the program;
- b. Conduct a monthly assessment to evaluate the effects of the program in relation to the overall peace and order situation in the locality;
- c. Provide for an effective mechanism to obtain volunteers, facilities and technical expertise;
- d. Any other functions as necessary.

**Section 3. SEPARABILITY CLAUSE** - If any provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

This Executive Order shall take effect immediately.
