AN ORDER DESIGNATING MR. LAURO D. MONZON, OFFICER-IN-CHARGE, OFFICE OF THE CITY ADMINISTRATOR, AS AN ALTERNATIVE SIGNATORY FOR ALL MANILA BAY REHABILITIATION PROGRAM-RELATED DOCUMENTS

WHEREAS, in the 2008 Decision of the Supreme Court En Banc, the Supreme Court ordered government agencies to clean up, rehabilitate, and preserve Manila Bay, and restore and maintain its waters to make them fit for swimming, skin-diving, and other forms of contact recreation;

WHEREAS, the Department of the Interior and Local Government issued a Memorandum Order on June 5, 2011, ordering the local government units to take "notice of the continuing mandamus" Order of the Supreme Court, and to adhere with the Constitutional mandate to manage and maintain ecological balance in accord with the harmony and rhythm of nature. All concerned City Mayors and *Punong Barangays* are enjoined to take in, and to regularize the cleaning-up of "*esteros*", rivers and other waterways within their jurisdictions that exit into the Manila Bay;

WHEREAS, to facilitate the efficient processing and timely submissions of necessary documents in compliance with the mandates abovementioned, it is imperative to designate an alternative signatory for all Manila Bay Clean-Up, Rehabilitation and Preservation Program Local Government Unit Compliance Audit-related documents on behalf of the City Mayor, Hon. Alex L. Advincula;

NOW, therefore, I, **HON. ALEX L. ADVINCULA,** City Mayor of the City of Imus, Province of Cavite, by virtue of the powers vested upon me by law, do hereby order the designation of **MR. LAURO D. MONZON, Officer-In-Charge, Office of the City Administrator,** as an alternative signatory for all Manila Bay Clean-Up, Rehabilitation and Preservation Program Local Government Unit Compliance Audit-related documents.

Section 1. Repealing Clause- All executive issuances, orders, rules and regulations or parts thereof inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

Section 2. Separability Clause- Should any provision of this Executive Order be declared unconstitutional or invalid, the other section or provisions not affected thereby shall remain in full force and effect.

Section 3. Effectivity- This Executive Order shall take effect immediately upon the approval hereof and shall remain in full force and effect unless sooner revoked or amended by the Local Chief Executive.
