**AN ORDER RECONSTITUTING THE CITY OF IMUS LUPONG
TAGAPAMAYAPA INCENTIVES AWARDS (LTIA) COMMITTEE**

WHEREAS, the Katarungang Pambarangay (KP) was created under Presidential Decree No. 1508, date 11 June 1978, which formally organizes a system of time-honored Filipino tradition of amicably settling interpersonal disputes at the barangay without judicial recourse;

WHEREAS, the Lupong Tagapamayapa, herein referred to as Lupon was empowered under the system to mediate, conciliate and/ or arbitrate disputes in a barangay to promote the speedy administration of justice;

WHEREAS, the committed and dedicated performance of the Lupon's has brought the success of the Katarungang Pambarangay over the years:

WHEREAS, in recognition of the Lupon's contributions in the promotion of the Katarungang Pambarangay objectives, Section 406b of the Local Government Code (Republic Act 7160) mandates the Department of the Interior and Local Government to grant economic or other incentives to outstanding Lupons.

NOW, THEREFORE, I, ALEX L. ADVINCULA, City Mayor of City of Imus, Cavite by virtue of the powers vested in me by law, do hereby order:

- b. Disseminate information on the Awards to generate awareness and support from the public and private sectors within the city;
- c. Select and submit to the Provincial Awards Committee the best performing lupos within the city;
- d. Secure funding and counterpart prizes from the partner agencies and the private sector; and

e. Plan and implement appropriate awarding ceremonies.


Section 3. Technical and Secretariat Services- The DILG City Office shall provide technical and secretariat services to the committee.

Section 4. Separability Clause- If any provisions of this Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

Section 5. Repealing Clause- All orders, rules, regulations and issuances, or parts thereof, which are inconsistent with this Order are hereby repealed, amended or modified accordingly.

Section 6. Effectivity Clause- This Order shall take effect immediately upon signing hereof, unless sooner revoked, repealed or modified.
